चांदी की टकसाल, जौहरी बाजार, सांगानेरी गेट, जलमहल सहित कई जगहों पर पानी भरा। ऐसे ही हालात शहर के बाहरी क्षेत्रों में भी देखने को मिले। कालवाड़ रोड और महारानी फार्म के गायत्री नगर में जलभराव की शिकायतें आई।

# जयपुर बढ़ता गया, बीवीजी कंपनी का बिल घटता गया

- कंपनी ने सॉलिड वेस्ट मैनेजमेंट रूक्स की सारी परिभाषाएं ही बदल डाली
- सख्ती हुई तो घटती गई कचरे की मात्रा

जयपुर (कासं)। प्रदेश की राजधानी होने के नाते हर वर्ष जयपुर की आबादी कुछ फीसदी बढ़ती है। आबादी बढ़ने के साथ शहर में उत्पादित कचरे की मात्रा भी बढ़नी चाहिए, लेकिन घर-घर कचरा संग्रहण कर रही बीवीजी ऐसे में कहा जा रहा है कि कंपनी शुरूआत से ही जयपुर के साथ धोखाधड़ी का इरादा रखती थी। जयपुर नगर निगम के कर्ता-धर्ता और अधिकारी लालच में नहीं आते तो यह कंपनी कभी की जयपुर से बाहर हो जाती। निगम सूत्रों का कहना है कि बीवीजी कंपनी ने अप्रेल 2017 में काम शुरू किया। शुरूआती महीनों में 2-4 वार्डों में ही वह काम



शुरू कर पाई थी। उसे शहर के 91 वार्डों को कवर करने में 9 से ा 10 महीनों का समय लगा। ऐसे में कंपनी के शुरूआती बिल कम आने चाहिए थे। अनुबंध के अनुसार, कंपनी को 1340 टन कचरा प्रतिदिन घर-घर से उठाना था, लेकिन शुरूआती महीनों में ही उसके बिल 1800 से 2100 टन प्रतिदिन कचरे के आने लगे। बाद में सख्ती होने पर कंपनी के बिल 1500 टन प्रतिदिन तक आ गए। नगर निगम और बीवीजी के बीच अब विवाद ही इन बढ़े हुए बिलों का है। सबसे पहली बात तो निगम को यह बढ़े हुए बिल स्वीकार ही नहीं करने चाहिए थे। यदि निगम ने बिल लिए तो उनमें हाथों हाथ कटौतियां की जानी चाहिए थी और बढ़ी हुई मात्रा को हटाया जाना चाहिए था, लेकिन बढ़े हुए बिल स्वीकार करके कंपनी को एवज में 50 फीसदी भुगतान कर दिया गया। ऐसे में अब कंपनी उन बढ़े हुए बिलों का भी पूरा पैसा मांग रही है। उस समय कंपनी पर आरोप भी लगे थे कि वह घर-घर कचरा संग्रहण करने के बजाए ओपन डिपो और मिट्टी–मलबा उठाकर कचरे का वजन बढ़ा रही है। इन आरोपों की गूंज बोर्ड बैठकों में भी हुई, लेकिन नतीजा कुछ नहीं निकला। कंपनी लगातार बढ़े हुए बिल निगम को पेश करने लगी। ऐसे में कुछ अधिकारियों ने कंपनी की मनमानी पर लगाम लगाने के लिए उसे नोटिस भी जारी किए गए। शिकायतें बढ़ती देख कचरे की निगरानी और सत्यापन के लिए इंडिपेंडेट इंजीनियर लगाए गए तो कंपनी के बिलों में कचरे की मात्रा कम होनी शुरू हो गई। यदि कंपनी के बिलों का ग्राफ बनाकर देखा जाए तो यह चोरी साफ नजर आ जाती है, इसके बावजूद कंपनी को बिलों के एवज में 50 फीसदी भुगतान होता रहा और कंपनी खुशी-खुशी उसे स्वीकारती रही। जानकार बता रहे हैं कि यदि कंपनी घर-घर कचरा संग्रहण करती तो वह आज तक 1340 टन के आंकड़े को नहीं छू पाती। कंपनी ने हमेशा घर-घर कचरा संग्रहण के बजाए ओपन डिपो से कचरा उठाना जारी रखा, क्योंकि इसमें ही उसे फायदा नजर आ रहा था। यही ओपन डिपो नगर निगम कंपनी को दी जा रही रेट से काफी कम में उठवाता था। कंपनी को शुरूआत में 1650 रुपए प्रति टन की दर दी जा रही थी, जो अब बढ़ कर करीब 1900 रुपए प्रतिटन तक पहुंच गई है। जबकि नगर निगम ओपन डिपो 350 से 600 रुपए प्रति टन में उठवाता था।
